Minutes of the Regular Meeting

January 21, 2015

I. and II. Opening and Attendance at Meeting.

A Regular Meeting of the Long Branch Sewerage Authority was called to order at 3:00 p.m., prevailing time, on Wednesday, January 21, 2015, by the Chairman, Mr. Blaisdell in the Meeting Room at the Authority Administration Building, 150 Joline Avenue, Long Branch, New Jersey, attended by Mr. Booth and Mr. Mazza. Mr. Brown arrived at 3:03 p.m. and Mr. George arrived at 3:05 p.m.

In addition to the Members of the Authority hereinabove-stated, there were present at said Regular Meeting the following professional attaches: Executive Director, Joseph A. Martone; John L. Bonello, Esq., Authority Counsel; John Van Dorpe and Tom Roguski of the firm Maser Consulting, Authority Engineers; David Kaplan, Authority Auditor; Laurie Hartnett, PCC Officer; and Elisabete Vieira, Secretary.

III. Announcement Pursuant to New Jersey Open Public Meeting Act.

Adequate Notice of this Regular Meeting and of all Regular Meetings for the Year 2014, has been provided by publication thereof in the *Link* on February, 27, 2014, as a "legal" advertisement and in the *Asbury Park Press* on February 22, 2014, as a "legal" advertisement and by forwarding duplicates thereof on February 20, 2014, to the Clerks of the City of Long Branch, Borough of West Long Branch and Borough of Monmouth Beach for filing in their respective offices and for posting in a public place in each such Municipality.

IV. Public Participation.

Mr. Haber addressed the board regarding his property at 729 Woodgate Ave. He stated that his sewer line is not connected to the main line but instead connected through the neighbor's backyard. Mr. Haber feels that he is paying for a yearly service and not receiving any assistance from the Authority with regards to his sewer line on his private property. Mr. Martone explained that Mr. Haber's line was installed back in 1968. There was a manhole that came off Bowyer and went through an easement which is located in Mr. Haber's neighbors backyard, the plumber

connected Mr. Haber's line to the existing manhole. Mr. Martone explained that the Authority's rules and regs state that in no condition does the Authority maintain any sewer lines on private properties. Mr. Martone suggested that the Authority could run a new lateral to the curb at the Authority's expense but Mr. Haber would still be require to have a plumber run his new line from the lateral at the curb to his house. Mr. Haber stated that wouldn't be an option for him.

The board denied his request for a refund or for any assistance with the sewer line on his private property.

On Motion by Mr. Blaisdell, seconded by Mr. Mazza, and passed by the affirmative vote of all members present, no nays, no absent, no abstain, all actions taken, and dispositions made by Mr. Haber with regards to the property at 729 Woodgate Ave have been denied.

Secondly Mr. Minoia and Mr. Tint from Diversified Realty Advisors addressed the Board. They explained that they are the current owners of the Long Branch Partners LLC., which acquired all of the Broadway Arts Center properties. They are working closely with the City regarding the redevelopment of the new proposed project which will include approximately 700 units of multi families and 100,000 squares feet of associated retail space. Mr. Minoia explained that there are 70 units that have been vacant for a few years and would like to possibly request relief on the sewer charges for the years 2014 and 2015.

The board suggested a discontinuance / reactivation fee for all the vacant accounts. This fee will be for the years of 2014 and 2015. If the project is not concluded within these two years, an appeal will be required. The following resolution was presented:

WHEREAS, the Long Branch Sewerage Authority has determined that it is appropriate to remove the 2014 and 2015 service charges including accumulated interest for the unoccupied properties owned by Long Branch Partners, LLC., listed on the prepared spreadsheet, attached hereto to this Resolution and made a part hereof, and

WHEREAS, Long Sewerage Authority will add a reactivation fee of \$121.00 per unit per year for the aforementioned accounts, and

NOW, THEREFORE, BE IT RESOLVED by the Long Branch Sewerage Authority that its Executive Director is hereby authorized to discontinue service charges and remove the outstanding charges referenced hereinabove together with any interest due and will add the reactivation fee of \$121.00 per unit per year, and

BE IT FURTHER RESOLVED, that an extension appeal will be required after the two year period has expired and for any addition units shall be considered an application for sewer service at the current connection fee rate, de novo, and subject to the procedures and costs set forth in the Rules and Regulations of the Long Branch Sewerage Authority, and

BE IT FURTHER RESOLVED, that the Executive Director be authorized to execute any further documents or instruments necessary to effectuate this Resolution.
